**At present this work is only 1 to 2 percent complete.**

In the present format, this document when complete will have about 300 pages, including 220 pages of family listings and 80 index pages.

This work in progress includes genealogies of families who resided in the town of Shelburne, Franklin county, Massachusetts. The town of Shelburne was in Hampshire county until 1811, at which time Franklin county split off from Hampshire county. The town of Shelburne includes that portion of Shelburne Falls village which is east of the Deerfield River; the portion of Shelburne Falls west of the river is in the town of Buckland. Shelburne town also includes a rural portion, sometimes known as Shelburne Center, which is not in Shelburne Falls village. In the 19<sup>th</sup> century, Shelburne and Shelburne Falls were generally considered to be distinct and non-overlapping.

This work is intended to complement similar genealogies which have been published for the adjacent towns of Buckland, Colrain, Conway, and Deerfield. Families in the Buckland portion of Shelburne Falls village were discussed by Fannie Shaw Kendrick and Lucy Cutler Kellogg in *The History of Buckland, Massachusetts, 1779-1935* (Town of Buckland, 1937), and are not fully covered here.

Like all genealogies, this work has errors and omissions, and reflects some guesswork. For improvement in future revisions, the author requests, and depends upon, contributions from readers. Blank family information forms are included, for submission to the author.

**Confidentiality:** In order to protect individual privacy, personal information about living persons is generally restricted in the United States. For example, U.S. Census data are not publicly released until 72 years after the date of the Census. Because this work is intended for electronic publication and widespread distribution, privacy constraints (even on public information) are applied more strictly than is customary or required by law. In

this work, information is published only about persons who are known to have died, or who were born more than 100 years ago, or who have given permission for publication.

**Coverage:** When complete, this work will cover all known families who ever lived in Shelburne, subject to the confidentiality restrictions described above. All known deceased persons in a family will be mentioned, even only one family member resided in Shelburne. Living family members will be mentioned anonymously, for example "two other children, both living 2001." At the author's discretion, some families outside Shelburne will be included in order to clarify family relationships. Isolated individuals who cannot be linked to families will be listed in a separate section.

**Information on living persons:** The author privately maintains information on living persons, and will provide that information upon request, for verification and correction. Information about a deceased person will automatically appear in future revisions of this work, after that person's death. If you wish to be included prior to your death, you may submit the Permission for Publication form in the back of this document. A separate signed form is required from each living adult who wishes to be included. No information will be published about living minor children. If both spouses are living, whether or not still married, marriage information will be published only with permission from both spouses.

**Organization:** Surnames are arranged alphabetically. Within each surname, families are arranged by generation under the earliest known ancestor. Each family head has a unique identifier, for example me20. These identifiers, rather than page numbers, are used to link records, and appear in the Index. Some earlier paternal ancestors outside Shelburne are indicated, for example "MERRILL, John 1706/7 (Nathaniel 1664/5, Nathaniel 1633, Nathaniel 1601)."

For families that originated outside Shelburne, the arrival date in Shelburne of family head is indicated if known, for example "arr. S abt. 1773." Each family record includes (1) information about the male family head; (2) information about each of his marriages; (3) information about each of his children. A child having his/her own family record is so indicated with an identifier in parentheses, e.g. (me30). Daughters' families are listed under their husband's surname.

**Sources:** Information has been obtained from family members, and from public primary sources including vital records, church records, 1790-1920 U.S. Census, 1855 and 1865 Massachusetts Census, cemetery inscriptions, land records, probate records, town directories, telephone books, school yearbooks, maps, newspaper articles and obituaries. Important secondary sources include books and notes by William O. Taylor, Lucy Cutler Kellogg, Leila Stone Bardwell, Elmer F. Davenport, and Doris A. Wheeler; and family genealogies. Source information for specific data items will be provided upon request.

**Abbreviations:**

*General:* aft. after; abt. about; arr. arrived; b. born; bef. before; bur. buried; co. county; cr. cremated; d. died; husb. husband; rem. removed (moved) to; res. resided; unk. unknown; un. unmarried..

*Towns and villages:* B Buckland (Town); S Shelburne (Town); SF Shelburne Falls (Village). Towns and villages are in Massachusetts (MA) unless specified. Standard U.S. state abbreviations are used.

*Cemeteries:* A Arms; C Center (Franklin); E East (Skinner); H Hill (Old Village); Ha Hawks; S South. Arms is in Shelburne Falls; Hawks is in Deerfield, on the Shelburne town line; the others are in Shelburne.

**Formats:** Surnames at birth, in particular women's maiden names, are capitalized. Double dates, *e.g.*, 1731/2 (which occur only from January 1 to March 15 prior to 1752) resolve ambiguities due to the calendar change which occurred in 1752; they do *not* indicate an uncertainty in the date.

## The Format of this Document

For this report we have chosen *not* to use the standard report format which appears in most published genealogies. The standard format was originally designed to report all the descendants of a single ancestor. Technically, a *genealogy* is a single descendant tree, although the term is also used to denote the study of family *pedigrees*, i.e. ancestor trees, or family relationships in general.

In a single genealogy or descendant tree, the original male ancestor is customarily given the number 1 and is listed under the heading "Generation 1." All his children are listed in order, usually with small Roman numerals. In addition, his sons who have known offspring are given numbers 2, 3, etc. and are identified with those numbers. Under the heading "Generation 2," his sons have individual family records labeled 2, 3, etc. Each of those records has the same structure as record 1. For example, if the original ancestor had two sons with offspring, then his sons' family records 2 and 3 appear under "Generation 2," and his grandsons' family records 4, 5, 6, appear under "Generation 3," etc. This format works well for a single genealogy, regardless of whether all descendants or only the male descendants are considered.

The standard format is less useful for a collection of genealogies, for example of all the families in a town. In *A History of Deerfield (1895)*, George Sheldon maintained the standard genealogical format, restarting the numbering sequence and assigning the number 1 to every new original ancestor. Grandchild 17 might be identified, for example as "son of (5)," which is confusing because there can be several different "5" records on the previous few pages. Within a given descendant tree, all the sons' family records are followed by all the grandsons' family records, and so on. However, since every descendant tree has a different original ancestor, Sheldon did not identify "Generation 1," "Generation 2," etc.

In *A History of Colrain, Massachusetts (1974)*, Lois McClellan Patrie adopted a hybrid numbering scheme. Within a given descendant tree, each family is identified by a capital Roman numeral signifying its generation, followed by an Arabic numeral. As with Sheldon, family records within a descendant tree are ordered by generation.

Authors of other town collections of genealogies, for example Deane Lee in *Conway 1767-1967 (1967)*, chose to avoid any numbering scheme. Sons having offspring are simply marked with an asterisk in the father's family record, and the children's family records are unnumbered. A different type face distinguishes the sons' family records from the father's family record. The children of the father, and the children of the sons, are listed in a third type face. Fortunately for Lee, he needed to consider only three generations, i.e. two levels of family records.

In the present work the family records are ordered as in the other town collections of genealogies. That is, descendant trees are ordered by the original ancestor's surname and given name, and family records within a descendant tree are ordered by generation. In this work, each family record is uniquely identified with a four-character code, e.g. **me01**. The two letters are the first two letters of the surname, for example **me** for MERRILL. The two-digit numeric code is a unique code assigned to each male family head. The numeric codes are assigned in ascending order, though not necessarily consecutively. As far as possible, families of the same generation have the same leading digit; e.g., **me60**, **me61**, etc. In the Index, each person is uniquely identified by his/her surname, given

name, and birth year. In some cases the birth year is estimated. Index entries are keyed not to page numbers but to the four-character codes, so that minor revisions or a repagination of this document does not necessitate an update of the Index. In general, each male appears in his father's family record and his own family record; each female appears in her father's family record and (if married) in her husband's family record. With the present indexing scheme, *without leaving the index*, one can quickly identify the close kin of a given person. For example, Cordeanio Harley MERRILL b.1840 is listed with codes **me51** (his father's family record) and **me60** (his own family record). Cordeanio's father is Moses Whitney MERRILL b.1817, who has codes **me40** and **me51**. All of Cordeanio's other close kin, including his siblings, spouses, and children, have index entries which include the code **me60**. The advantages of this innovative indexing scheme will become quickly obvious to the reader.

## Estimated Size of Document, When Complete

Census data were used to estimate the size of this document, when complete. In 1850, 1900 and 1920 the population of Shelburne was 1239, 1508, and 1437 respectively. Below, we list the most prevalent surnames. Minor variations, for example FISK and FISKE, are combined.

To date only the surname MERRILL has been included in this work. In the three Censuses there were an average of 19 MERRILLs in Shelburne. In this document, there are 22 MERRILL families, 2.9 pages of family listings, and 1.1 index pages. Based on the format presented here, the final document is expected to be about 300 pages, including 220 pages of family listings and 80 index pages. Of course there will be more pages if the page size is reduced.
